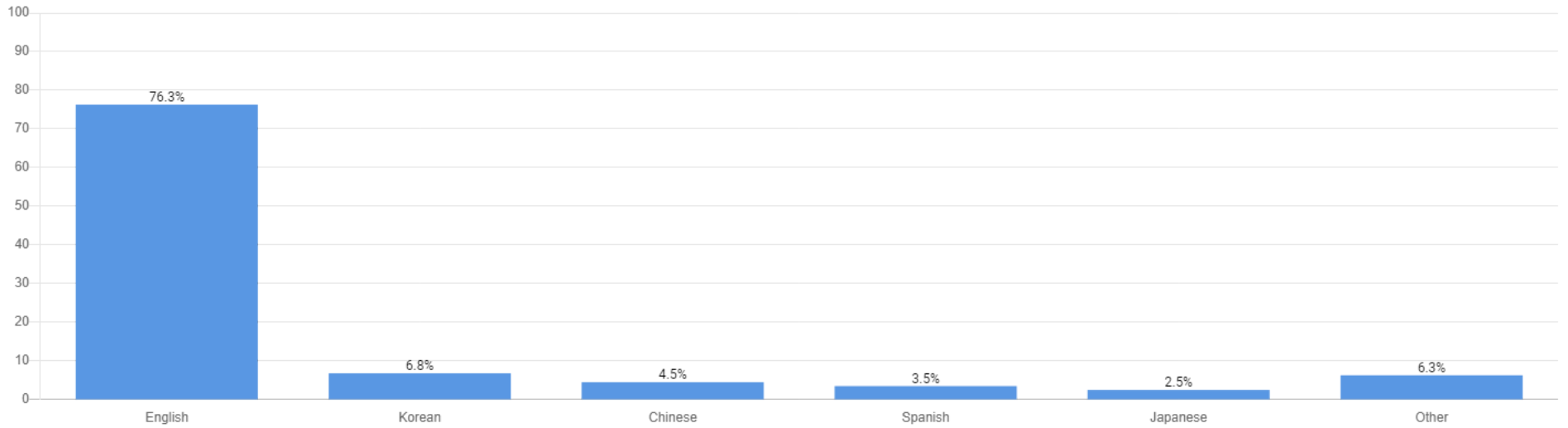

Student Growth

Student growth is a measure of how much students are learning each year. Each student receives a Student Growth Percentile (SGP) for English Language Arts (ELA) in grades 4 through 8 and for Mathematics in grades 4 through 7 that explains their progress compared to students who had the same test scores in previous years.

A student's SGP falls between 1 and 99 and can be grouped into three levels:

Low Growth: Less than 35

Typical Growth: Between 35 and 65

High Growth: Greater than 65

If the student growth percentiles for all students in the school are ordered from smallest to largest, the median student growth percentile (mSGP) for the school is the percentile in the middle of that list. English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment. The Proficiency Rate for Federal Accountability measures is the percentage of students that met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. NJSLA results for 2018-19 include only students in grades 3 through 10. Students that were enrolled for less than half a school year are excluded from performance results. The table below provides participation rates, proficiency rates, annual targets and status in meeting the targets, and statewide proficiency rates.

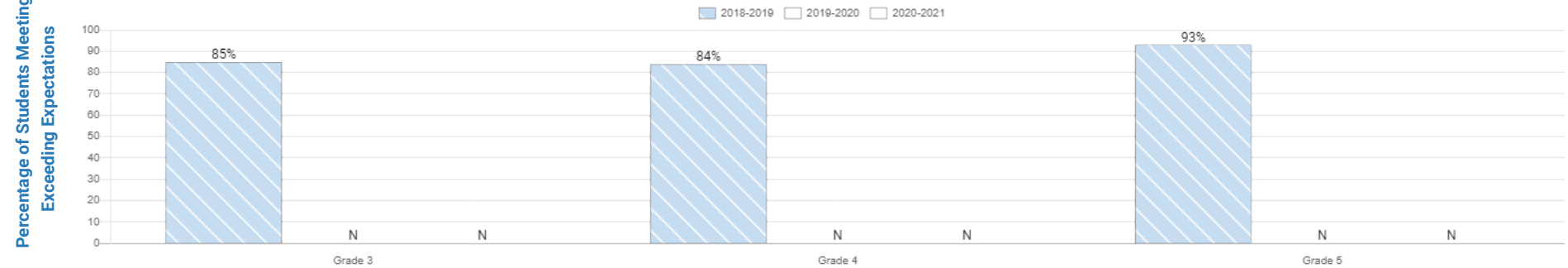

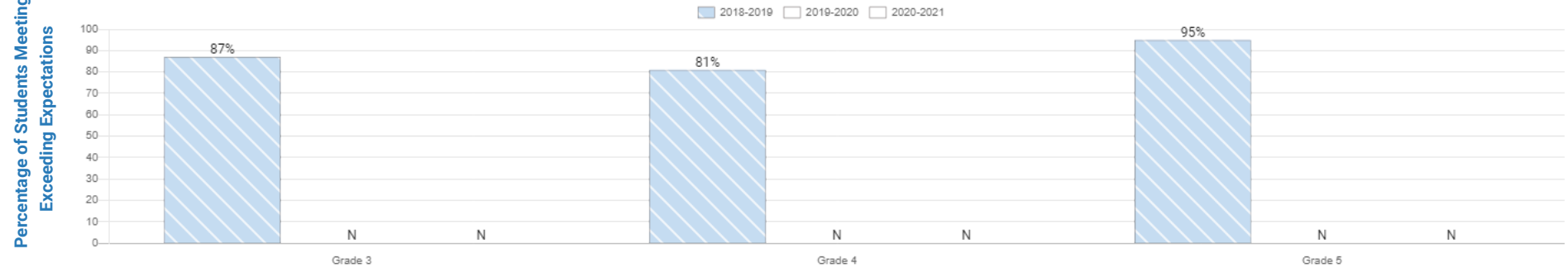

English Language Progress to Proficiency

A student's expected growth is based on the student's initial year proficiency level and student growth expectations are increased by equal intervals each year so that the student meets the proficiency cut score of 4.5 within five years. The table shows the annual target for the percentage of students making expected growth and whether that target was met.

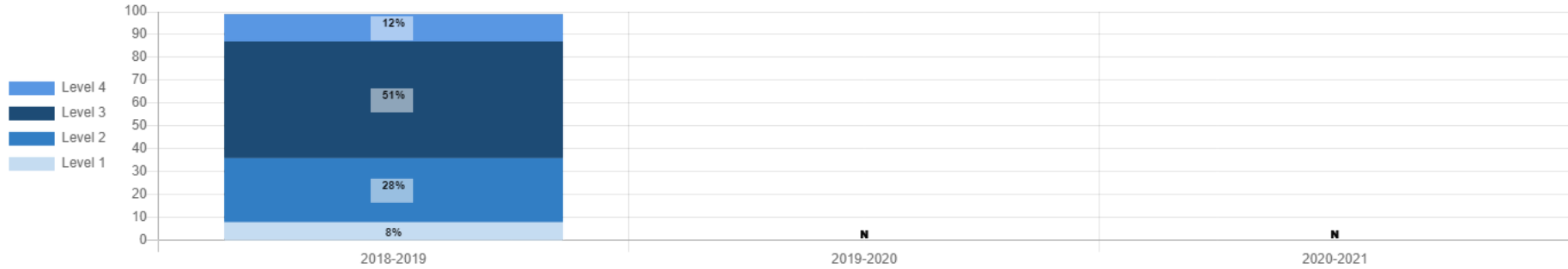

All students in grades 5, 8, and 11 will take the NJSLA-Science assessment. Students receive a score of Level 1, 2, 3, or 4 where levels 3 and 4 represent proficiency. 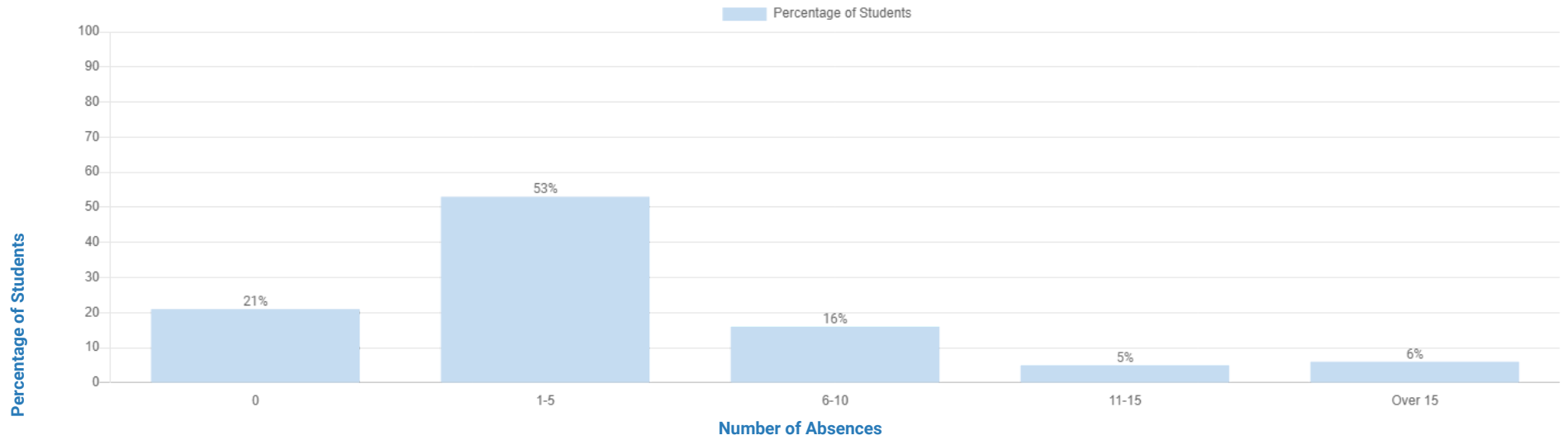

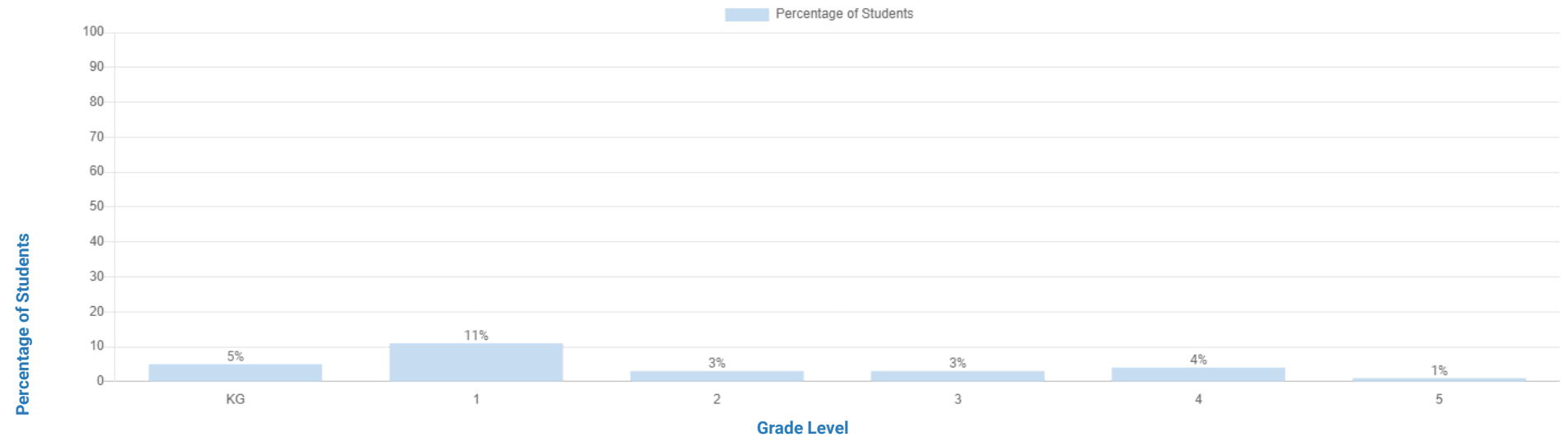

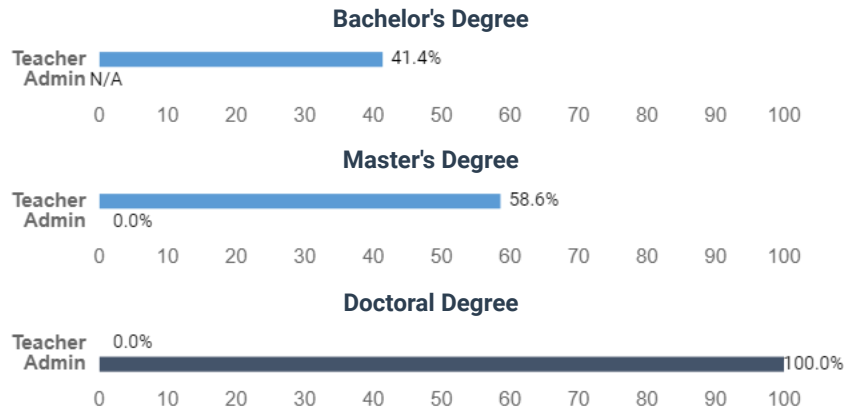

Important Note for 2020-2021: Due to the COVID-19 pandemic, New Jersey received waivers from the United States Department of Education (USED) in both [March 2020](#) and [March 2021](#) that waived accountability-related requirements in the Elementary and Secondary Education Act (ESEA) for the 2019-2020 and 2020-2021 school years. These waivers removed the requirements to:

- Calculate indicator scores and summative scores for the 2019-2020 and 2020-2021 school years;

For the categories that are identified every three years, the last identification occurred in the 2018-2019 school year (based on 2017-2018 data) and the next identification was scheduled for the 2021-2022 school year (based on 2020-2021 data). As a result of these waivers, the next identification will be delayed until the 2022-2023 school year (based on 2021-2022 data) and all currently identified schools will be eligible to exit status at the end of the 2022-2023 school year.

For the annual identification of schools for Targeted Support and Improvement: Consistently Underperforming Student Group, no schools will be identified during the 2020-2021 or 2021-2022 school year as a result of these waivers. The next identification is scheduled for the 2022-2023 school year.

Staff and Professional Learning:

Professional development in Ridgewood is organized around the district's identified annual goals. New teachers participate in a rich orientation program that begins in the summer and extends across the school year. New teachers are further developed through our New Teacher Induction Program which includes structured professional development and support for the first four years of employment. Professional development days involve teachers in collaborative curriculum work, and the district supports teachers' participation in learning opportunities outside of Ridgewood. The district has made a strong commitment to Orton Gillingham training for its K-12 staff. RPS offers a robust inservice program taught by our own staff who have expertise on a variety of special topics. The district has also partnered with Great Schools Partnership to advance the goals of the district strategic plan.



Student Supports and Services:

Guidance Counselors and Child Study Teams work closely with students and their families, and teachers consistently integrate differentiated instructional strategies. RPS have partnered with CarePlus of NJ, a fully licensed and accredited mental health care organization, to provide a school-based counseling program which directly supports students and their families. The therapists are experienced in youth development, therapy and case management and utilize a variety of effective models to develop skills and strategies for personal growth.

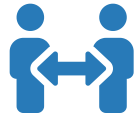
School Safety:

Ridgewood Public Schools continue to add to our already significant school safety and security protocols. The district funds the position of School Security Specialist and a School Resource Officer is funded by the district and local municipality. All of our buildings have lockdown shades installed throughout, building exterior management systems, and utilize a district-wide lockdown system.



Technology and STEM:

Students are afforded opportunities in STEM education from grades 3-12 through required and elective courses, and the middle schools and high school utilize makerspace classrooms to deliver relevant STEM curricula. Technology is integrated throughout the K-12 curriculum, and students in grades 2 through 12 operate on a one-to-one chromebook platform. Teachers are trained in technology applications to enhance the instructional experience, and significant investment has been made in instructional technology. RPS have implemented a significant number of appropriate, technology based instructional tools to facilitate remote learning for students who may be quarantined due to COVID-19. Through the use of technology and support from IT professionals and technology coaches, the district provides instructional services to all students, and enhancements are implemented as needed.



Learning During COVID-19:

The RPS Reopening and Operations Plan, a comprehensive description of the district's educational and safety protocols, aligned to the NJDOE The Road Back. In 2020-21, RPS operated under a hybrid schedule with half of the students attending school in person in the morning on alternating days. Lunch and virtual learning took place in the afternoon at home. The district goals were to engage students in learning through the application of grade-level academic knowledge and skills, while also enabling students to connect socially. Virtual instruction integrated a blend of synchronous and asynchronous activities, and student submission of work was assessed consistently. Teachers provided instruction using a variety of methods, and differentiation took place through provisions for student choice on certain assessments. Mental health support was available from the school based mental health team, while support was provided to families and staff by the Mental Health Coordinator.

Other Information:

Hawes Elementary School is a caring learning community with a population of approximately 396 students in grades kindergarten through five. Visitors immediately sense the warmth and spirit of cooperation present at Hawes. Parents and teachers work together to provide an academically challenging curriculum and culturally rich environment for our children. Recognizing that the ability to read and write is the foundation for success in all academic disciplines, developing a literate student body is a primary focus of the educational program and staff development initiatives. Teachers collaborate with one another to differentiate language arts instruction using the workshop model. Using literature and informational texts as guides, students learn the skills necessary to become truly literate readers and writers. Children publish personal narratives, memoirs, essays, realistic fiction, and informational pieces. The elementary mathematics program combines the practice of foundational skills with problem solving. Our goal is for the students to apply their knowledge of mathematics to life situations in an accurate, efficient, and thoughtful manner. Enrichment activities, as well as support programs, provide the children with an exemplary experience in mathematics. An inquiry-based science program gives our students opportunities to make predictions, collect data, take notes, graph information, reach conclusions, and create hypotheses. Hands-on experiences with earth, environmental, life, and physical science materials allow students to develop both process and thinking skills and apply them in making decisions and solving real-world problems. The study of communities, cultures, and history is the basis of our social studies program. Grade level teams implement units of study designed to allow children to experience the traditions of others and life in the past. Infused in all lessons is the importance of showing respect to individuals and groups.
