1 Call to Order [00:04:35] Bruce called the meeting to order at 7:00 pm. Roll call of directors present: Clayton - present, Dave T - present, Tim - present, Robert - present, Bruce - present.

2 Meet the candidates (Discussion). Candidates for positions of Danville School Board Director. Times represent meeting recording time stamps in *mm:ss* {minutes seconds}. A transcription of each candidate's comments is provided.

- **Clayton Cargill** (07:50 to 08:58) Candidate for **3-year** position as a director

COMMENTS My name is Clayton Cargill. I'm asking again to be set back down into my 3-year seat that I ran for 3 years ago and sat in. When I sat three years ago - when I asked to be seated 3 years ago in this seat, what I told you what I was interested in is positive outcomes for the students in the school, and the way to do that was to improve the teaching environment. I wasn't sitting down into the job to make drama, and I wasn't sitting down into the job to do anything other than learn what I was doing and do the best that I could at what I was doing. And as I came in and in the course of two or three years, I definitely received an education in how to sit on the board. It is really a learning process. and I think that there are several people that will remember me having said "I don't understand what you're saying -- say it again, so I can learn it along the way." And I think with that experience going forward that I will be a better board member than I have been, and I promise that I will always come to meetings as prepared as possible. And I will always maintain a transparent standard. Thank you.

- **Melissa Conly** (09:19 to 10:45)* and (12:50 to 14:11)** Candidate for **1-year** position as a director. There was significant noise* in the audio transmission for some connected to the meeting, and so Robert asked the Chair to permit Melissa to repeat her comments. Bruce agreed she could do so, if she wanted to. Melissa said she would "revisit the highlights."** Only the first set of recorded comments is transcribed.

COMMENTS Thank you, Bruce. Good evening, everyone. My name is Melissa Conly. I've lived in Danville for 11 years now. I'm the parent to a middle schooler in the school at this time. - **Molly Gleason** (14:49 to 16:18) Candidate for **1-year** position as a director

COMMENTS Hi everyone. My name is Molly Gleason. And first off, I'd like to thank the board members for serving and giving their time. You know the last few years have been incredibly challenging for everyone, especially the school, and I hope to bring the same dedication and professionalism to the position that you all have. So, my husband, Adam, and I live in West Danville with our two kids. Amelia is in 5th grade and Ethan is in 2nd grade. I grew up in a small town in Maine, and Adam graduated from Danville and has a long family history here on the Webster side of the family. And you know we both appreciate the connection Danville school has with the community, and I'm so grateful our kids get to go to Danville, where their peers are like family, and you know teachers are invested in the education and well-being of every student. - **Lance Horne** (16:50 to 19:56) Candidate for **1-year** position as a director

COMMENTS Hi everyone, Lance Horne. I grew up in Danville. Allison and I have been high school sweethearts since freshman for me, sophomore for her. And she came down to Rhode Island with me when I went to business school, and I got a Bachelor's in Business Administration and have spent the last 20 years or so of my career doing non-profit fundraising. So, I've had many clients from the Veterans of Foreign Wars to children's health hospitals to all kinds of different needs -- that of [looking at] lymphoma, March of Dimes -- all kinds of different walks of life. I've done fundraising from a strategic standpoint, an account management standpoint, a production-operations management standpoint, and I kind of went around to different agencies and production facilities, and currently I work for a company out of Tulsa that has 26 different companies that reports into it. And I currently am in a client-phasing, on-boarding role. So, it is looking at a lot of the budgets and looking at what their needs are, or their fund-raising needs, whether it is DR-TV or direct mail or email - donor cultivation. So, in dealing with so many different, diverse organizations and folks, I've really kind of developed a good ability to work with people of all walks of life. I am very interested in promoting children's well-being and supporting the staff, getting them the tools that they need and the facility that we all dream for. Real big fan of the trade program that Mr. Schilling has proposed; that is something that this area really needs and definitely would be very interested in being part of that.
